The **Middle Trinity Groundwater Conservation District** ("MTGCD") Board of Directors will hold a Public Hearing on Proposed Amendments to District Rules on Thursday, November 4, 2021, at 1:00 p.m. at 930 Wolfe Nursery Rd, Stephenville, TX 76401. All interested parties are invited to attend.


The following items of business will be discussed, considered, and potentially acted upon by the Board of Directors of the Middle Trinity Groundwater Conservation District:

1. Call hearing to order and establish a quorum.
2. Public hearing on Proposed Amendments to District Rules. The proposed amendments to the District Rules include changes to (1) the District Rules definitions and terms, including the definition of "contiguous" and "contiguous boundary"; (2) the MTGCD's general permitting policies and procedures, including the term of operating permits and the spacing and location of new permitted wells; (3) permit application requirements; (4) the amendment of grandfathered permits; (5) the inter-relationship of county platting requirements and District rules; and (6) the repeal of language regarding Board structure and officers.
3. Receive public comments on Proposed Amendments to District Rules. Any person who desires to appear at the hearing and present comment or other information on the proposed Amendments to District Rules may do so in person, by counsel, or both. Comments may be presented verbally or in written form. Limits may be placed on the amount of time that each person is allowed to present verbal comments. The hearing posted in this notice may be recessed from day to day or continued where appropriate.
4. Discuss, consider, and/or action on Proposed Amendments to District Rules. Changes may be made to the proposed District Rules based upon comments received or made at the hearing, and the rules may be adopted with or without such changes without further notice or hearing.
5. Adjourn, recess, or continue rulemaking public hearing; written record may be left open for a limited time.
