## Coryell County RFP 2024-02 Request for Proposals for Grant Writing & Management Services

Coryell County is seeking to enter into a professional services contract with a competent **consultant/managing** firm to assist the <u>pre-award and post-award</u> management of its proposed Public Assistance (PA) project(s) if funded by FEMA through the Texas Division of Emergency Management (TDEM).

The following outlines the Request for Proposals.

1. Scope of Work: The management consultant or firm to be hired is to provide contract-related management services to the County including, but not limited to, the following:

- Grant Writing and Application Preparation
- Respond to Requests for Information (RFI) regarding FEMA projects
- · Assemble Environmental and Historic Preservation Review (EHP), if required

- Act as Liaison between the County, State, and FEMA
- Attend workshops and meetings related to the development and submission of the application

  - Describe the service providers capacity to perform as well as resumes of all employees who will or may be assigned to provide services if your firm is awarded a contract through this solicitation
